

Just after intermission, the maestro gave a joyous and moving tribute to his upbringing in MB.

The event was an unqualified success in every way. Thank you to everyone who attended the concert. You helped create a uniquely special event for Morro Bay and for the Open Space Alliance. A huge thank you to St. Timothy's Catholic Church for allowing us to use their beautiful venue, with amazing acoustics and a terrific piano. MBOSA is still hearing from people about the concert, with comments like, "It was a truly classy event" to wanting Morro Bay to have more events like it. We had about 230 paid attendees, yielding almost \$20,000 toward the purchase of Cerrito Peak/Eagle Rock. In the wake of the concert, we have had over \$10,000 in donations for the peak purchase.

CHEVRON TORO HILLS STATUS and PROP 68

In our past newsletter we updated the status of the effort to acquire Chevron's Toro Hills property for conservation. As you know, the strategy has shifted to acquiring parcels piecemeal — but in a strategic sequence that reflects the top priorities that the conservation team defined.

A new wrinkle in the story is Prop 68, the Parks, Environment, and Water Bond that was approved by 57.5% of voters in June 2018. The proposition authorizes issuance of \$4 billion in general obligation bonds for state and local parks, environmental protection, water infrastructure and flood protection projects. According to Becky Bremser of the Trust for Public Land (TPL), the Chevron Toro Hills conservation project is a "shovel ready" project that TPL hopes to qualify for funds under this proposition. She says the state is anticipating earmarking \$1 billion in bonds in this fiscal year, which may give an established project like Chevron an advantage.

The conservation team, led by TPL, selected priorities including maintaining open space between Morro Bay and Cayucos; helping create a new section of the California Coastal Trail; keeping the dog beach; and maintaining the viewsheds along that stretch of Highway 1. Given these priorities, you can see why the conservation team has made acquisition of parcel #1 (the northern parcel that straddles Highway 1) the top priority. Two more priority parcels in TPL's strategic plan are the 'shore plant' that is next to Highway 1 south of Toro Creek road and the parcel containing the old Texaco pipeline that leads from Del Mar Park up into the Toro Hills along Alva Paul Creek. Both of these offer great opportunities for passive recreation and/or beach access, high priorities of the Coastal Commission as well as Morro Bay residents.

One problem is that these higher priorities are also in parcels that have significant outstanding remediation issues. As you may remember, one of the reasons to switch to a piecemeal approach to acquisition was that Chevron has not completed required remediation on a number of parcels. Both the shore plant and the Alva Paul pipeline corridor will need a lot of work to make them suitable for public uses.

So, once more: dueling priorities. The idea of trails leading up into the Toro Hills from Del Mar is so great that we're really pulling for that option to be accelerated.



GENERAL PLAN UPDATE on SPHERE OF INFLUENCE

The process to update the General Plan is rapidly reaching conclusion — at least until the Council takes hold of it. We have talked before about the revised Sphere of Influence (SOI), and here is an update.

In short, not much has changed in the past 1.5 years. The SOI proposed in the General Plan update covers the area in the Chevron Toro Creek parcels above North Morro Bay and down into Toro Creek Valley. It greatly expands the current SOI, but makes great sense given the developmental potential of the Toro Hills property. The City needs to have a say in how that land is used.

The map included here is taken from a city diagram. It shows the SOI in red-hatched area, all of which is outside the city's current limits.



This area includes two of the high priority areas in the Trust for Public Land conservation plan. The Chevron Shore Plant is on the east side of Highway 1, just south of the small purple area. And the Alva Paul Creek parcel runs from the green blob north of the blue Del Mar Elementary School toward the NE (the green blob is Del Mar Park).

These county lands will remain in the County, zoned as agriculture. Each parcel in this zone may permit one dwelling plus a secondary dwelling unit, though the utilities they need are problematic to say the least.

Some of these parcels may become more active pieces in the chess game that is attempting to create a conservation in the Toro Hills.
