

# Task 1. Project Visioning

- Project vision drafted. Minor revisions anticipated, pending community meeting and GPAC outreach.
- What is resilience?
  - The Rockefeller Foundation (100 Resilient Cities) defines urban resilience as "the capacity of individuals, communities, institutions, businesses, and systems within a city to survive, adapt, and grow no matter what kinds of chronic stresses and acute shocks they experience."



# Task 2.1. Community Baseline Assessment

- Comprehensive overview of existing conditions in the planning area
- Identifies key assets and issues
- Serves as technical foundation for Plan Morro Bay






- Annexation Feasibility
  - Potential opportunities and constraints for land adjacent to city limits
- Air Quality and Greenhouse Gas Emissions
  - Existing air quality issues
  - Developing a GHG inventory update





- Coastal Resiliency
  - Sea level rise model for multiple years
  - Identifies assets exposed to sea level rise









- Cultural Resources
  - Tribal and historical resource review
- Economic Trends
  - Trade area, market leakage, and market segmentation information






- Infrastructure and Public Services
  - Infrastructure related to energy, water, wastewater, etc.
  - Services and service providers in the city
- Land Use, Community Form, and Coastal Uses
  - Existing and regulatory conditions








- Natural and Environmental Hazards
  - Vulnerability of life and property to hazards in the city
- Natural Resources
  - Plants, animals, and habitat








- Noise
  - Existing noise conditions
  - Conducted on-site noise recordings
- Parks, Recreation, and Open Space
  - Inventory of physical assets and programs
  - Includes coastal access







- Shoreline Erosion and Protection
  - Protective devices in place and historic erosion issues
- Transportation and Mobility
  - Traffic counts, VMT estimates, active transportation network
- Water and Water Quality
  - Watershed description, including issues related to water quality





## Vulnerability and Resilience Assessment

- Pulls assets from the Community Baseline Assessment
- Includes projections through 2040 for demographic and climate conditions
- Reviews asset vulnerability and resilience capabilities
- Allows the City to develop policy based on best understanding of future conditions








# Staffing and Roles






